The applicant agrees that FreeMate may, at any time, increase or reduce the applicants FreeMate dollar account credit limit, although it will not increase the credit limit beyond the level requested by the applicant and understands that FreeMate may at its discretion require the applicant to provide a guarantee, cash deposit or other security acceptable to FreeMate as security for the applicants performance as a member of the exchange.

In consideration for performing services specified in the FreeMate terms and conditions the applicant agrees to pay FreeMate a transaction charge at the rate of 8% cash fee of the transaction purchase made through the exchange. In no circumstances is FreeMate (or any other person) obligated to redeem FreeMate trade dollars for AUS cash currency. All members agree and understand that \$1 FreeMate trade dollar is equal to \$1AUS Dollar for valuation purposes. FreeMate will send each member regular statements by way of email showing their barter and cash account balances, and provide facilities for the members to download their statements and invoices from the FreeMate Website. Any cash amount owing to FreeMate must be paid within 7 days of receipt of that statement or sooner if requested by FreeMate. All liability of any kind of FreeMate to any member with respect to the services provided by it or other FreeMate members (whether arising under the Consumer Guarantees Act or any other enactment or otherwise) is excluded to the fullest extent permitted by law.
